In compliance with DIS 102, Hq, 35th Inf Div, 24 June 1945, submitted below is report of operations.

## 1 June 1945.

The 110th Medical Battalion maintained its position in the 35th Infantry Division. The Division still assigned to the XVI Corps and the Ninth US Army. The Battalion left present areas by motor movement enroute vicinity of Koblenz, Germany. Arrived Andernach, Germany, where all units were billeted overnite.

2 June 1945 to 15 June 1945 incl.

The Battalion moved by motor with the units locating as follows: Hq and Hq Det, 2d Plat Clr Co and Coll Co C at Brodenbach, Germany; Coll Co A at Kattenes, Germany; Coll Co B and 1st Plat Clr Co at Gemunden, Germany. The Division was relieved from duty with the XVI Corps and assigned to the XXIII Corps and the 15th US Army. The Battalion training is stressing physical fitness and care of equipment.

Clearing Station operating and processing Division and attached units personnel, both sick and injured. Collecting Companies performing evacuation both from the Aid Stations to the Clearing Station and from the Clearing Station back to higher Medical Installations. During this period, there were one hundred eighty-three patients from the Division and eleven from other units not attached handled through the Clearing Station. In addition, Coll Co C furnished one Medical Officer and an enlisted detail for the delousing of Displaced Persons at Neuwied, Germany. Co C same at Ehrenbreitstein, Germany.

16 June 1945 to 30 June 1945.

The Battalion entered on a four-week training schedule covering physical condition, military discipline, technical training, care of equipment and stressing competitive athletics and the maintaining of a high state of morale. The Battalion entered a team in the Division Softball Tournament and was defeated in the first round. The TO:
