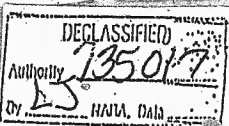

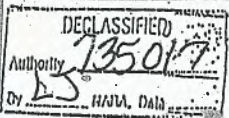

1. Omitted.
2. 35 Inf Div (less 137 Inf, 654 TD Bn and 448 AAA AW Bn):
 - a. Continues occupation, organization, security and Military Government of KOBLENZ Sub-Area.
 - b. Continues operation of Sanitary Cordon along RHEN R in Z.
3. a. 137 Inf, after relief in present area of responsibility, is attached to Brig Gen JESMOND D. BALMER for operational duties in the SAARLAND-PFALZ-HESSEN Sub-Area.
b. 134 Inf continues occupation, organization, security and Military Government of present area and relieves 137 Inf of these duties in Landkreis COCHEN and Landkreis ZELL. Relief to be by mutual arrangement of commanders concerned and to be completed by 032300Z July 1945.
c. 320 Inf continues occupation, organization, security and Military Government of present area and relieves 137 Inf of these duties in Landkreis ST GOAR and 654 TD Bn in Landkreis KOBLENZ. Relief to be by mutual arrangement of Commanders concerned and to be completed by 032300Z July 1945.
d. 35 Div Arty continues occupation, organization, security and Military Government of present area and relieves 137 Inf of these duties in Landkreis SIMERN. Relief to be by mutual arrangement of commanders concerned and to be completed by 032300Z July 1945.
e. 654 TD Bn, after relief in present area of responsibility, is attached to Brig Gen JESMOND D. BALMER for operational duties in the SAARLAND-PFALZ-HESSEN Sub-Area.
f. 448 AAA AW Bn is relieved from attachment to 35 Div Arty and is attached to Brig Gen JESMOND D. BALMER for operational duties in the SAARLAND-PFALZ-HESSEN Sub-Area.
g. 784 Tk Bn continues in Corps Res in present location, prepared for movement on six (6) hours' notice.
h. 35 Cav Ren Tr (less 2d Plat continued on duty at Fifteenth Army Hq) move to BIRKENFELD with mission of constituting Div and Corps Res.
i. 10 Belgian Fus Bn remains attached to Div Arty with continued static guard duties only.
j. 205 French Trk Co - Atchd to 320 Inf effective 050900Z July 1945.
