1. COUNTERINTELLIGENCE:

At GELSENKIRCHEN A5523 placed in local jail Kriminal Secetaire of the Gestapo, Herr Enssen, also a Sturmfuhrer in the SS, pending investigation of him and persons connected with him. This man will be evacuated to Camp Q within the next few days.

At LUDINGHAUSEN A8053 arrested SACURNA, Theodore H J member found with rubber blackjack and dagger. Sent to Camp Q as security threat. Arrested 6 officials on Kreis level at Coesfeld, the details on which are pending completion of a general survey in that area.

At RECKLINGHAUSEN A6335 arrested SCHLUETER, Franz, ortsguppenleiter of Hochlaer-Markt. Evacuated to Camp Q. Continued search for TENHOLD, Wilhelm, Gestapo president of Muenster, reported to be in the area. SCHLUETER, Franz, Ortsgruppenleiter, evacuated to Camp Q. GNICHWITZ, Alfred, Kriminal Secetaire of the Gestapo, Recklinghausen office. Sent to Camp Q.

At RUER A5232 sent HELLMAN, Heinrich, Ortsgruppenleiter to Camp Q. Began investigation of an incident between three Russian civilians and two American soldiers in which one of the Russians was injured by a grenade; also an investigation of wire cutting and wire monitoring of 95th Div telephone lines in the vicinity of Ruer-Esse. Report not received to date.

2. MISCELLANEOUS:

a. "T" Targets:

1. New "T" Targets to be seized and safeguarded - none.
2. "T" Target No. 3, Bank Vault at MUNSTER A926739 released from intelligence classification but responsibility of guarding remains unchanged. (Target is presently located in 320th area)

b. Weather - Continued overcast throughout the day and tonight with light intermittent showers.

SUBJECT: Military Censorship.

TO : Commanders, All Units.

1. Reference letter, Headquarters Fifteenth Army, Subject: "Military Censorship", dated 18 May 1945, with specific reference to par. 1.
