1. ENEMY:

a. Intelligence and CI activities:

- (1) Security control of civil population - No incidents.
- (2) Resistance organizations - Negative.
- (3) Internal security - No incidents.
- (4) Port, frontier, and travel security control - Ten persons violated Movement of Persons Notice at Landkreis of BIRKENFELD L1659. Tractor was impounded from one individual for using it for personal benefits while traveling with MG pass for procurement of agricultural products.
- (5) Visa security affecting US Forces - At about 1300 hours a communications line was cut vic L723985. It was a ground-strung line and evidently cut with wire cutters. Investigation is under way, but as yet no evidence has been found leading to suspicion of any persons. A communications line also was cut at about 1200 hours vic L750945. Investigation is being made.

b. Action taken on Intelligence Targets - Inspected concentration camp for political prisoners located at BRUTTIG L639702. Buildings of the camp have been looted and several of the buildings are being used to house refugees - no documents of intelligence value were found.

Inspected ANDERNACH F7604 insane asylum. Doctor in charge had been arrested and nothing of an intelligence value was found.

c. Evidence of possession of arms by German Nationals - None.

d. Attempts by civilians to evade regulations - No incidents.

e. Persons detained and reasons therefore:-

DENNERT, Thekla - NEIDERSPAY L8493, Landkreis St. Goar

Reason for arrest - Interrogated by Summary Court Officer relative to false statements made to MG concerning number of fruit baskets in her possession. Released in custody of the Burgermeister and detained for trial.

RUFLE, Jakob - OCHTENDUN G L7594

Reason for arrest - Volunteer SS man. Landkreis of Birkenfeld, arrested two SS men and the Landesbayerfuhrer from the Gau of Bezirk Koblenz and Trier. arrested two SA men; automatic arrest category - Names of men will be included on tomorrow's report.

Personnel of the Division may state in personal correspondence that they are in the XXIII Corps and 15th Army. Personnel may also state their exact location.

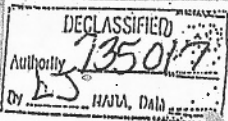

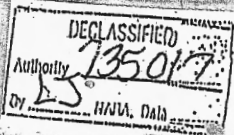
