I. AWARD OF BRONZE STAR MEDAL. By direction of the President, under the provisions of AR 600-45, 22 September 1945, as amended, and under authority contained in Circular No 32, Headquarters European Theater of Operations, United States Army, 20 March 1944, as amended, the Bronze Star Medal is awarded to:

Lieutenant Colonel Clinton E. Adams, 0229716, Medical Corps, 41st Evacuation Hospital, United States Army, for meritorious service in connection with military operations from 15 June 1944 to 31 March 1945. Entered military service from Texas.

Lieutenant Colonel Arthur K. Chapman, 0367231, Infantry, 7th Armored Group, United States Army, for meritorious service in connection with military operations from 20 February 1945 to 9 April 1945. Entered military service from Florida.

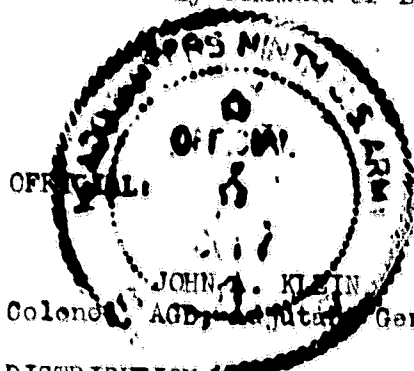

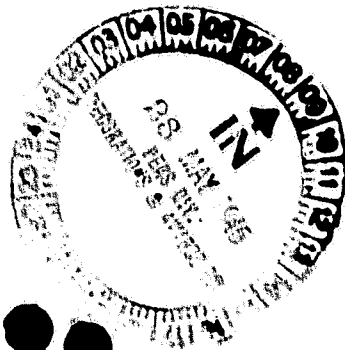
