I. AWARD OF BRONZE STAR MEDAL. By direction of the President, under the provisions of AR 600-45, 22 September 1943, as amended, and under authority contained in Circular No 32, Headquarters European Theater of Operations, United States Army, 20 March 1944, as amended, the Bronze Star Medal is awarded to:

II. AWARD OF MERITORIOUS SERVICE UNIT PLAQUE. Under authority contained in Section I, Circular No 345, War Department, 23 August 1944, the Meritorious Service Unit Plaque is awarded to:

The 472nd Ambulance Company for superior execution of duty in the performance of exceptionally difficult tasks. From 31 October 1944 to 31 March 1945, the 472nd Ambulance Company rendered meritorious service in the accomplishment of its numerous duties on the continent.
