I. AWARD OF BRONZE STAR MEDAL. By direction of the President, under the provisions of AR 600-45, 22 September 1943, as amended, and under authority contained in Circular No 32, Headquarters European Theater of Operations, United States Army, 20 March 1944, as amended, the Bronze Star Medal is awarded to:

Lieutenant Colonel James F. Barnard, 0347779, Medical Corps, 176th Medical Battalion, United States Army, for meritorious service in connection with military operations from 24 December 1944 to 4 May 1945. Entered military service from California.

Lieutenant Colonel Harry F. Cameron, Jr., 0371208, (then Major and Lieutenant Colonel), Corps of Engineers, 164th Engineer Combat Battalion, United States Army, for meritorious service in connection with military operations from 2 August 1944 to 3 May 1945. Entered military service from California.

Captain Jacob Goldman, 01312910, (then First Lieutenant and Captain), Infantry, 4th Information and Historical Service, United States Army, for meritorious service in connection with military operations from 20 September 1944 to 1 May 1945. Entered military service from New York.

Captain Samuel H. Ritter, 0333185, Corps of Engineers, 172nd Engineer Combat Battalion, United States Army, for meritorious service in connection with military operations from 1 March 1945 to 27 March 1945. Entered military service from Iowa.

Captain Norman B. Sigband, 01056553, (then First Lieutenant and Captain), Coast Artillery Corps, 4th Information and Historical Service, United States Army, for meritorious service in connection with military operations from 9 September 1944 to 1 March 1945. Entered military service from Illinois.

First Lieutenant Herschel B. Jones, 01013385, (then Second Lieutenant and First Lieutenant), Infantry, 4th Information and Historical Service, United States Army, for meritorious service in connection with military operations from 10 September 1944 to 1 May 1945. Entered military service from Tennessee.

First Lieutenant Robert E. Merriam, 01321648, (then Second Lieutenant and First Lieutenant), Infantry, 4th Information and Historical Service, United States Army, for meritorious service in connection with military operations from 20 September 1944 to 15 March 1945. Entered military service from Illinois.

Second Lieutenant Irving Levine, 01305076, Infantry, 4th Information and Historical Service, United States Army, for meritorious service in connection with military operations from 10 November 1944 to 1 May 1945. Entered military service from New York.

Master Sergeant David M. Lippincott, 32970829, (then Technical Sergeant and Master Sergeant), Infantry, 4th Information and Historical Service, United States Army, for meritorious service in connection with military operations from 1 February 1945 to 1 May 1945. Entered military service from New York.

Master Sergeant Marvin R. Watson, 36869857, Corps of Engineers, 172nd Engineer Combat Battalion, United States Army, for meritorious service in connection with

military operations from 17 February 1945 to 27 March 1945. Entered military service from Michigan.

Clodfelter, 39603303, (then Technician Fourth Grade and Technician Third Grade), Infantry, 4th Information and Historical Service, United States Army, for meritorious service in connection with military operations from 9 September 1944 to 1 May 1945. Entered military service from Montana.

Sergeant Carlo P. Ucolini, 32803319, Quartermaster Corps, 3810th Quartermaster Truck Company, United States Army, for meritorious service in connection with military operations from 8 June 1944 to 18 April 1945. Entered military service from New York.

II. AWARD OF MERITORIOUS SERVICE UNIT PLAQUE. Under authority contained in Section I, Circular No 345, War Department, 23 August 1944, the Meritorious Service Unit Plaque is awarded to:

The 38th Traffic Regulating Group for superior execution of duty in the performance of exceptionally difficult tasks. From 20 January 1945 to 8 May 1945, the 38th Traffic Regulating Group rendered meritorious service in the accomplishment of its numerous duties on the continent. Throughout this period this unit achieved and maintained a high standard of discipline and demonstrated superior performance in every duty it was assigned.
