I --- BRONZE STAR MEDAL. Pursuant to authority contained in AR 600-45, dated 22 September 1943, as amended, and Memorandum 21, Headquarters Fifteenth United States Army, 4 March 1945, a Bronze Star Medal is awarded to the following:

Lieutenant Colonel Robert L Thompson Jr, 0241746, Field Artillery, United States Army, for meritorious service in connection with military operations against an enemy of the United States in France, Belgium, Holland, Luxembourg and Germany from 7 July 1944 to 8 May 1945. Entered military service from Kansas.

Chief Warrant Officer Arthur P Knopinski, W2105596, United States Army, for meritorious service in connection with military operations against an enemy of the United States in France, Belgium, Luxembourg, Holland, and Germany from 10 July 1944 to 8 May 1945. Entered military service from Illinois.

Master Sergeant Charles S Smith, 39282128, Coast Artillery Corps, United States Army, for meritorious service in connection with military operations against an enemy of the United States in France, Luxembourg, Belgium, Holland and Germany from 10 August 1944 to 8 May 1945. Entered military service from California.

First Sergeant Robert W Hogue, 16072079, Infantry, United States Army, for meritorious service in connection with military operations against an enemy of the United States in Germany from 8 February to 30 April 1945. Entered military service from Illinois.

Staff Sergeant Herbert W Singleton, 34663337 (then sergeant), Infantry, United States Army, for meritorious service in connection with military operations against an enemy of the United States in France and Germany from 9 July to 30 November 1944 and from 14 March to 30 April 1945. Entered military service from North Carolina.

Sergeant Lawrence E Hagle, 39622588 (then private first class), Infantry, United States Army, for meritorious service in connection with military operations against an enemy of the United States in France, Holland and Germany from 22 January to 8 May 1945. Entered military service from Montana.

Pursuant to authority contained in AR 600-45, dated 22 September 1943, as amended, and Memorandum 21, Headquarters Fifteenth United States Army, 4 March 1945, in addition to the Bronze Star Medal previously awarded, a bronze Oak-Leaf Cluster is awarded to the following:

Lieutenant Colonel John H Ninton 0324519, Field Artillery, United States Army, for meritorious service in connection with military operations against an enemy of the United States in France, Luxembourg, Belgium, Holland and Germany from 8 August 1944 to 8 May 1945. Entered military service from New York.

Lieutenant Colonel Kenneth W Reed, 0341038, Field Artillery, United States Army, for meritorious service in connection with military operations against an enemy of the United States in France, Belgium, Holland, Luxembourg and Germany from 3 September 1944 to 8 May 1945. Entered military service from Kansas.


