I --- SOLDIER'S MEDAL. Pursuant to authority contained in AR 600-45, dated 22 September 1943, as amended, and Memorandum 21, Headquarters Fifteenth United States Army, 4 March 1945, a Soldier's Medal is awarded to the following:

First Lieutenant Robert L Huey, 01293776, Infantry, United States Army, for heroism near * * * , Germany on 9 June 1945. Upon learning that a train loaded with ammunition for a twenty-four inch self-propelled gun was burning, this officer volunteered to lead a patrol, and, without hesitation, dashed to the scene of the fire, where, without regard for personal safety, he assisted in bringing the fire under control. By his heroic action, Lieutenant Huey undoubtedly prevented numerous casualties among civilians in the area, as well as serious property damage. Entered military service from Pennsylvania.

Staff Sergeant Domingo T Rodriguez, 38163113, Infantry, United States Army, for heroism near * * * , Germany on 9 June 1945. Upon learning that a train loaded with ammunition for a twenty-four inch self-propelled gun was burning, this enlisted man volunteered as a member of a patrol, and, without hesitation, dashed to the scene of the fire, where, without regard for personal safety, he assisted in bringing the fire under control. By his heroic action, Sergeant Rodriguez undoubtedly prevented numerous casualties among civilians in the area, as well as serious property damage. Entered military service from Texas.

Private First Class William Larison, 33839498, Infantry, United States Army, for heroism near * * * , Germany on 9 June 1945.
