The following points of information were disclosed by PW:

Alexander Radaczki Pole 5th Co. 1/2 916 Inf Regt. Yesterday the 6th, 7th, and 8th Co's were in line and the fifth in reserve. When the others suffered heavy casualties the 5th Co was committed also. Says that Germans have no rear installations.

Was in St. Lo 3 weeks ago on his way to his position. At that time the town had been put in ruins by air bombardment. States that there had been SS units in St Lo but that they have been recently withdrawn.

Ammunition allottment for LMG is 900 rounds per day.

Retreating troops do not use prepared installations but must dig new holes as they withdraw.

- f. Mission of companies in line was to hold line at all cost.
- g. In defending the hedge rows the Germans dig individual fox holes and often put up a machine gun at the corner of two hedge rows. Then they have a second line several hundred meters back which they build up with dugouts supported by wood. Five men occupy the gugout with a machine gun.
- h. PW heard of our tank attack at about 2100 last night. The sound of our tanks was pickked up.
- i. Although short in men within units, the enemy apparently has plenty of automatic weapons and we find generally two machine guns with each ten or twelve men.
- j. Reinforcements in the strength of 1 Bn (100 men) arrived in our 2nd Bn area at Mix 1900 last night. This is a reserve Bn of a previously identified whit.

Joseph Kunz - Polish. Fusilier Battalion 353. 4th Co. Strength 30 men. Suffered 15 casualties yeaterday. Have 4 of 12 heavy m.g. left; have 6 - 80 mm mortars about  $2\frac{1}{2}$  km behind lines.. Rumor that there are four SS divisions; including armored units, in the vicinity of St Lo, but he has not seen any SS uniforms.

The above are both deserters and have been planning to run over for some time.

No soldbuch. Has identification as Russian FW taken at Stalingrad. Worked in Staleg VI at Dortmund /p until January, 41, and then was taken to France 50 Km beyond St. Lo., Worked here with an artillery unit cle ming the horses. The artillery had horses but no guns. Unit identified as 8th Artillery Regt. Was brought to front two days ago and used to dig holes 100 yds to rear of firing line. States that these were new holes and the Germans had no previously prepared rear installations. Wears the uniform of a soldier but not the national emblem of the eagle and swastika.

PW was attached for duty with the 2nd Co. His morale is low because for the last 4 days he was busy on the telephone and at night he had to repair wires. When the American infantry attack came, he was ordered to call for reinforcements to units in the rear, but those did not arrive. This Fus.Bn was formerly the 371 RCN BN. Since this PW is from Hq ix he is not informed on the conditions of the companies, but he admits heavy losses in men.

The 14th company of a regiment is usually an Anti Tank Co, but this plateen was in the line armed with rifles and fighting as infantry men. They were attached to one of the battalions in line: did not know which: the battalion commander was wounded and probably killed - was a lst Lt, name unknown. The plateen normally has 3 75 mm AT guns but since these were committed as infantry troops the AT guns were left at an unknown place about 22 Km distant.

Gassimow, Kadir. Pvt. Same unit as above. Unable to speak German. Is Russian, and was taken PW by the Germans at Stalingrad.

Mobile Battalion also called Mobile Brigade. When at full strength it had 800 men, and contains 3 companies or squadrons. The men were formerly mounted on bicycles. Company strength is now down to 15 or 20 men. The unit came into line last night at 7 o'clock. This company had 2 lmg and rifles: no mortars. The PW was in St Lo about 8 pany had 2 lmg and says that everything has been completely destroyred and no soldiers are there.

The commanding officer of the brigade is Lt. Col Rateitz. PW believes that his company commander was killed by artillery fire today.

Before deserting to our lines he shot and killed a German noncom.

Others confirm this and say that they had shot noncoms and officers on several occasions before

The Brigade is composed of the 518, 513, and 517 squadrons or companies.

Thaddeus Kirzeniewski same unit as above.

Heard that there were two 88's somewhere to the rear, but he has never seen them. Also says he killed a sergeant before coming over.

Name: Emil Bracek, Pvt, 5th Co, 2nd Bn, 899th Regt, 260th Div. Vinko Leskovsek, Pvt, same unit. Both men are Jugoslavs.

PW state that their Co is made up half of Germans, half of Poles and Jugoslays. The unit was stationed before at Morlaix in Brittany from where their Bn arrived by bicycle. They were kept in reserve all the time while on this front because the Germans did not trust the foreign soldiers enough to put them into forward position. When the American attack came yesterday and the German companies suffered enormously from our mortar fire, these reserve troops were finally committed. The foreign soldiers had been waiting for such an opportunity to get closer to the American lines in order to desert. When the American infantry attacked, the German-born soldiers defended their position, but the foreigners stayed in their fox holes and refused to fight. The Germans took all MG away from them for fear that they be used against themselves. The German officer ran to several fox holes, threatening the jugoslaves and even sticking them with a bayonet. The PW claim that they shot several German NCO in the back, and that this was not the first time it happened either. Then the Americans strived and hurled hand grenades and the Germans fled while the Poles and Jugoslaves waived white handkerchiefs.

The PW claim that only 12 men were left out of a Co of 60. Many wounded were kept lying around for long hours with no medics in sight. They state the German lines are in complete disorder and that decimated units are being combined into new units so that no order of battle exist any longer.

These PW were captured by the 3rd Bn.

Only the second battalion of this regiment is present in the line. The Sth company which is normally a machine gur comp my is a rifle co in this case.

Both PW are national Germans, were taken by Co. L. Captured about C5CO Strength of eighth company is now about 15 men. The company has been in the line since about the first of the month. The remainder of the mer ere mostly Germans, the others having deserted. 8th Co has 2 81mm mortars. Early yesterday afternoon the company withdrew about 200 yards: there was no prepared position and they had to dig new heles.

When the prisoner was asked about the effect of the phosphorus shells he said it was as bad as the regular artillery, for which they have tremendous respect. He saw no one who had been burned by phosphorus, and although there was a let of smoke he said that no phosphorus shells landed in his immediate vicinity.

PW knew of no civilian snipers or contact with civilians at all. He had no snipers in his squad.

The 6th company had greater strength - about 40 men - because it had not been committed as often as the other companies of the battalion previously. The PV was a squad leader and his actual was cut off from the rest of the company. PV states that his company did not employ emipers and he also knew of no contacts with civilians nor had he heard of civilian smipers. His unit was greatly discouraged at the lack of German artillery and aircraft. He said that all they could do was to stay in their holes.

PW has seen no SS uniforms. He came thru ST Lo shout two weeks ago and says that the town was devoid of both soldiers and civilians.

PV has received no news other than German Army propaganda paper which was last issued about July 4th. He has not heard of our activities on other fronts.

PW was also on Ruseian front and states that the effect of the artillery and morter fire here is more fearful than in Ruseia.

6th So had 3 large resket launchers (88 mm) two of which were destroyed. Have also an unknown number of the smaller rocket laurshers.
